Thank you for your email regarding the updated mineral assessment (MA) for the above development proposal.

Having considered the MA's argument that, the amount of reasonably estimated mineral (Folkestone Formation) at 368,640 tonnes of recoverable mineral, significant but not strategic, and the difficulties in procuring suitable inert backfill (sub-soils) material to restore the site to form a developable area again is considered such that criterion 3 of Policy DM 7: Safeguarding Mineral Resources. As it concludes:

Considering the details summarised above and other factors discussed within the MSA included in Appendix B, the mineral resources found on site cannot be extracted in a viable or practical manner and that prior extraction cannot be undertaken without rendering the proposed B8 scheme undeliverable. On that basis the Ashford Road proposals comply with Policy DM7 of the KMWLP.

My view is that given the circumstances of the site's physical constraints and the difficulties that are likely to be encountered post mineral extraction is sufficient to invoke this exempting criterion of Policy DM 7: Safeguarding Mineral Resources. On that basis the County Council no longer raises an objection to the proposal on land-won mineral safeguarding grounds.
